LAUNCH OF ONLINE RTI PORTAL FOR HIGH COURT AND DISTRICT JUDICIARY OF GUJARAT

Based on the guidance and directions of Hon'ble the Acting Chief Justice, Hon'ble Judges of the I. T. Committee and the Rules Committee of the High Court of Gujarat, an Online RTI Portal has been developed in-house by the IT Cell of the High Court for the benefit of all applicants seeking information under the Right to Information Act, 2005 from the Registries of the High Court and District Judiciary of Gujarat.

As directed, this is to inform to all concerned that, the Online RTI Portal is being launched today i.e. 20th June, 2023 as a pilot implementation exercise facilitating online filing of all RTI Applications and RTI First Appeals for the High Court of Gujarat, all the District & Taluka Courts, all the Family Courts, Industrial & Labour Courts of the State of Gujarat and City Civil, Small Cause and Metropolitan Courts of Ahmedabad. The applicable fees and charges can be paid through e-payment using this Online RTI Portal. The portal is accessible from the website of the High Court of Gujarat, websites of all the District Courts and also from the direct link at <u>https://gujarathc-casestatus.nic.in/rtiportal/</u>.

For effective and smooth functioning of the Online RTI Portal to the optimum convenience of the stakeholders, Hon'ble the Acting Chief Justice and Hon'ble Judges have been pleased to approve the following modalities:

- 1. A citizen of India can register himself/herself on Online RTI Portal as a User for filing RTI Application and RTI First Appeals using a mobile number and an email address.
- 2. RTI Applications can be filed through the Online RTI Portal by uploading the PDF of the RTI application in prescribed proforma. In case of such an application being filed by the BPL (Below Poverty Line) Card holder, a Certified Copy or True Copy of BPL Card or Certificate issued in that behalf by the concerned Authority, should also be uploaded.

- 3. For the RTI Application being submitted through the Online RTI Portal, the fees and/or charges as provided in Rule 8 of Gujarat High Court (Right to Information) Rules, 2005 may also be paid through online payment.
- 4. For RTI Applications submitted through the RTI Portal, the reply to such application shall also be uploaded on the Portal by the office of the Ld. Public Information Officer and also sent as email to the RTI Applicant automatically by the Portal along with an SMS notification.
- 5. First Appeal before the Appellate Authority can also be filed through the Online RTI Portal challenging the replies of RTI Applications which were filed through this Portal, by giving the RTI Application Reference No. and uploading the First Appeal Memo in PDF. For the RTI Applications not filed through this Portal, First Appeal filing facility will also be separately provided, which would require uploading of RTI Reply as well.
- 6. The notices for hearing of the RTI Appeal shall be sent through email / SMS to the Appellant and will also be reflected on the RTI Portal. No hard copy notice shall be sent for appeals presented through Online RTI Portal.
- 7. In case of the First Appeal filed online through the RTI Portal, the order/reply to the appeal shall also be uploaded on the Portal and also sent as email to the RTI Appellant automatically by the Portal along with an SMS notification.
- 8. The applicable fees / charges and the practice of dealing with RTI Applications/Appeals by the office of the Ld. PIOs and First Appellate Authorities will be the same as currently being adopted.

A user guide explaining the features and functionalities of the Online RTI Portal, is appended herewith for the benefit and convenience of the RTI Applicants / Appellants.

1.INTRODUCTION

- An applicant who desires to obtain any information under the RTI Act can apply through this Web Portal.
- The word RTI stands for 'Right to Information'.
- This act empowers the citizens of India to get information from any government department, which is required to reply expeditiously or within thirty days.

2.USER REGISTER / LOGIN

• To apply for an RTI Application, an Applicant should first register by clicking *Sign Up* for New User.
